# The Lawyer Insurance

## THE LAWYER COVER

We have designed comprehensive insurance covers to address the various insurance needs of Lawyers in a single package. The insurance has been developed to cater for legal profession, work injury act (WIBA), office and home insurance.

### Section A: Professional Indemnity Insurance

#### Who is Covered

This section provides financial protection in the event that clients suffer financial loss as a result of negligent/non-professional acts, alleged wrongful or negligent advice. It covers breach of professional duty, defamation, loss of documents, breach of confidentiality, dishonesty and costs for disciplinary hearings.

### Section B: Accidental Injury and Work Illnesses (wiba)

Provides Insurance to Employees for both Occupational Injuries and Diseases arising out of I or in the course of employment. The cover has further been extended to provide for 24 Hours accidental Injuries and death.

### Section C: Office Property

Provides Insurance for office building(s) and contents as well as money risks, damages caused by fire, theft or attempted theft, accidental damage, fraud by employees, loss of cash in business premises and transit of business cash in the hands of authorized employees.

### Section D: Domestic Package Cover

This cover protects the insured household property against Theft risks, Fire risks and Accidental damage.

- Section A Building**  
This covers the insured's building against burglary, fire and related perils - **Premium rate 0.125% of the sum insured.**
- Section B Contents**  
This covers household contents against fire and associated perils, theft and burglary - **Premium rate 1% of the sum insured.**
- Section C All Risks**  
Covers the insured portable items i.e Cameras, Watches, Jewellery, Mobile phones etc. the risks covered are Fire, burglary and accidental damage - **Premium rate 1.5% of the sum insured.**
- Section D**  
Covers the Domestic workers against death and/ or Bodily Injury sustained whilst at work E.g Watchman, Gardener, Cook etc - **Premium is Kshs 500 per employee.**
- Section E Owner, Liability**  
Indemnifies the owner of the building in the event of any injury sustained by third parties due to negligence of the owner e.g due to poor state of construction or repairs etc - Premium Free upto 1 Million, then **Kshs 500** for every additional Kshs 1,000,000
- Section F Occupiers Liability**  
Indemnifies the occupier of the building in the event of any injury sustained by third parties due to his/her negligence e.g gas leakage - Premium Free upto Kshs 1 Million, then **Kshs 500** for every additional Kshs 1,000,000.

*Minimum applicable premium under domestic package is Kshs 3,000.*
