- 1. Pursuant to a special resolution passed by the unit holders at the Annual General Meeting held on 29<sup>th</sup> June 2021 allowing for virtual meetings, the meeting will be held virtually.
- 2. Any unitholder wishing to participate in the meeting should register using either of the following:

## a) Through the web portal

In order to complete the registration process, the unitholder will need to have their ID/Passport Numbers that were used to open the account. ## b) Unstructured Supplementary Service Data (USSD)

- 7. Unitholders are entitled to attend and vote at the AGM or entitled to appoint a proxy to attend the meeting and vote on their behalf.

  - ii. Physical copies of the proxy form are also available at the Registrars Offices at IKM Place, Tower B, 1<sup>st</sup> Floor, 5<sup>th</sup> Ngong Avenue. A proxy must be signed by the appointer or his attorney duly authorized in writing. If the appointer is a body corporate, the



instrument appointing the proxy shall be given under its common seal or under the hand of an officer or duly authorized attorney of such body corporate. - 8. The AGM will be streamed live via a link that shall be provided to all unitholders and proxies who will have been registered to participate in the AGM.
- 9. Duly registered Unitholders and proxies may vote (when prompted by the Chairman) for resolutions on a panel provided next to the live stream screen or via the USSD prompts.
- 10. Results of the AGM shall be published within 24 hours following the conclusion of the AGM. The results will also be available on the web portal.
